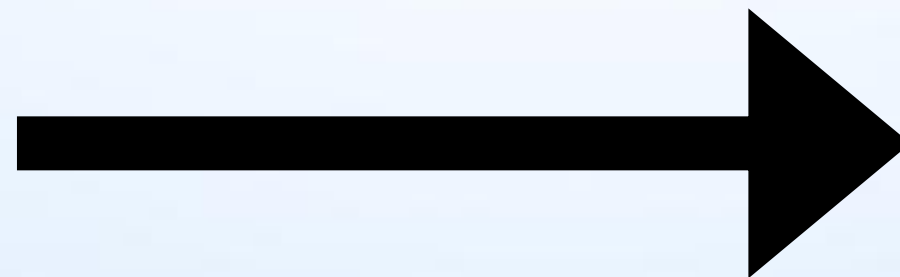

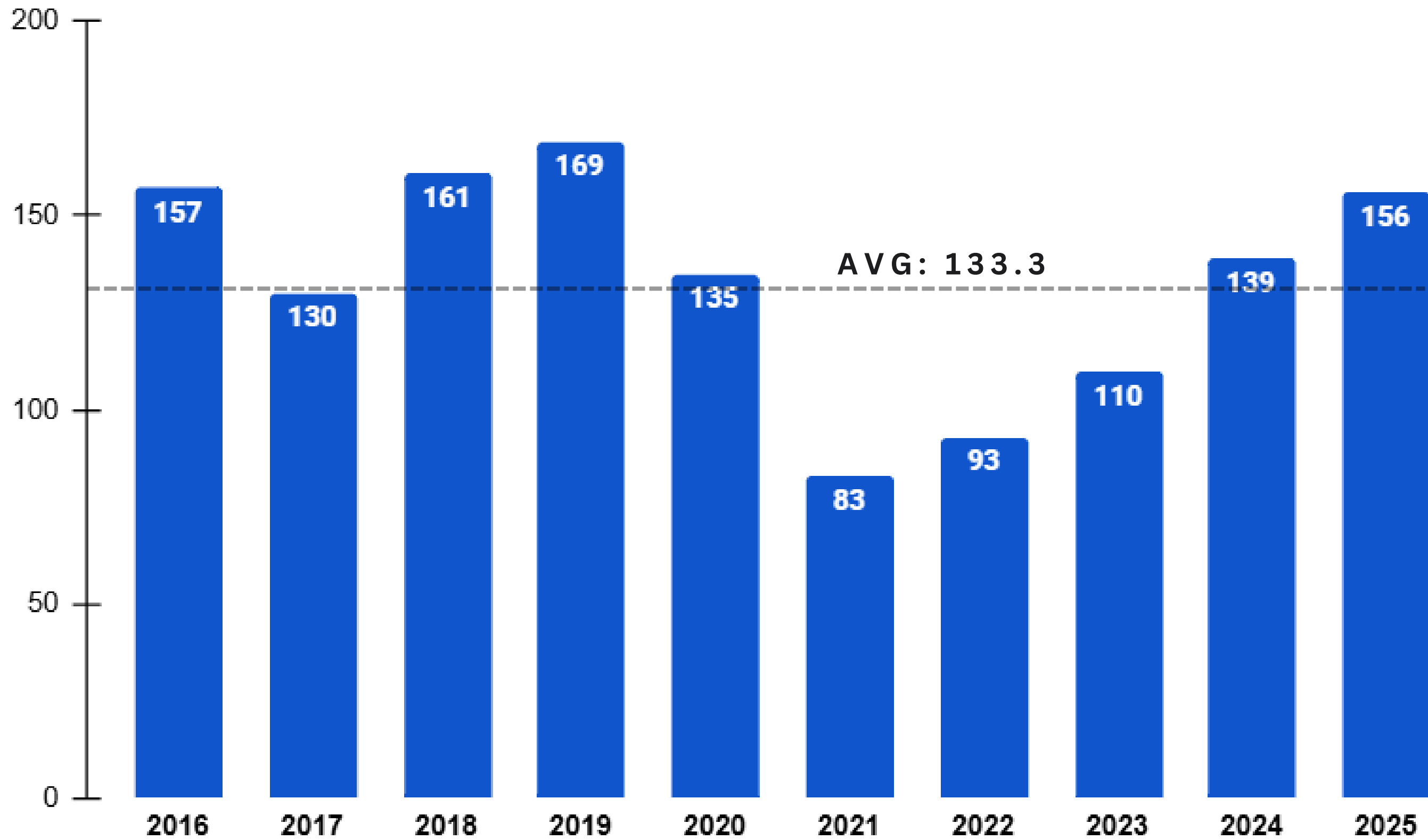

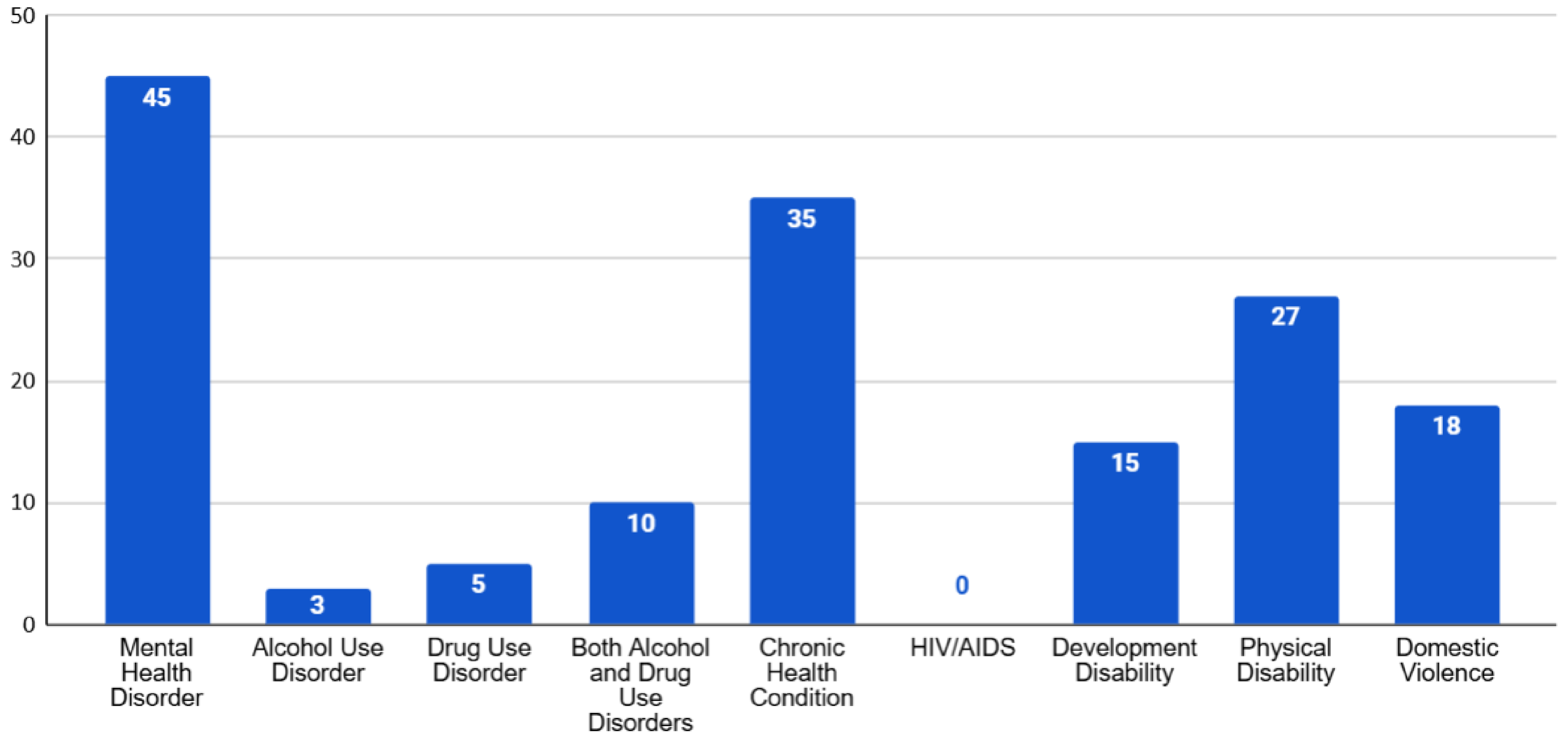

WHAT IS CHRONIC HOMELESSNESS?

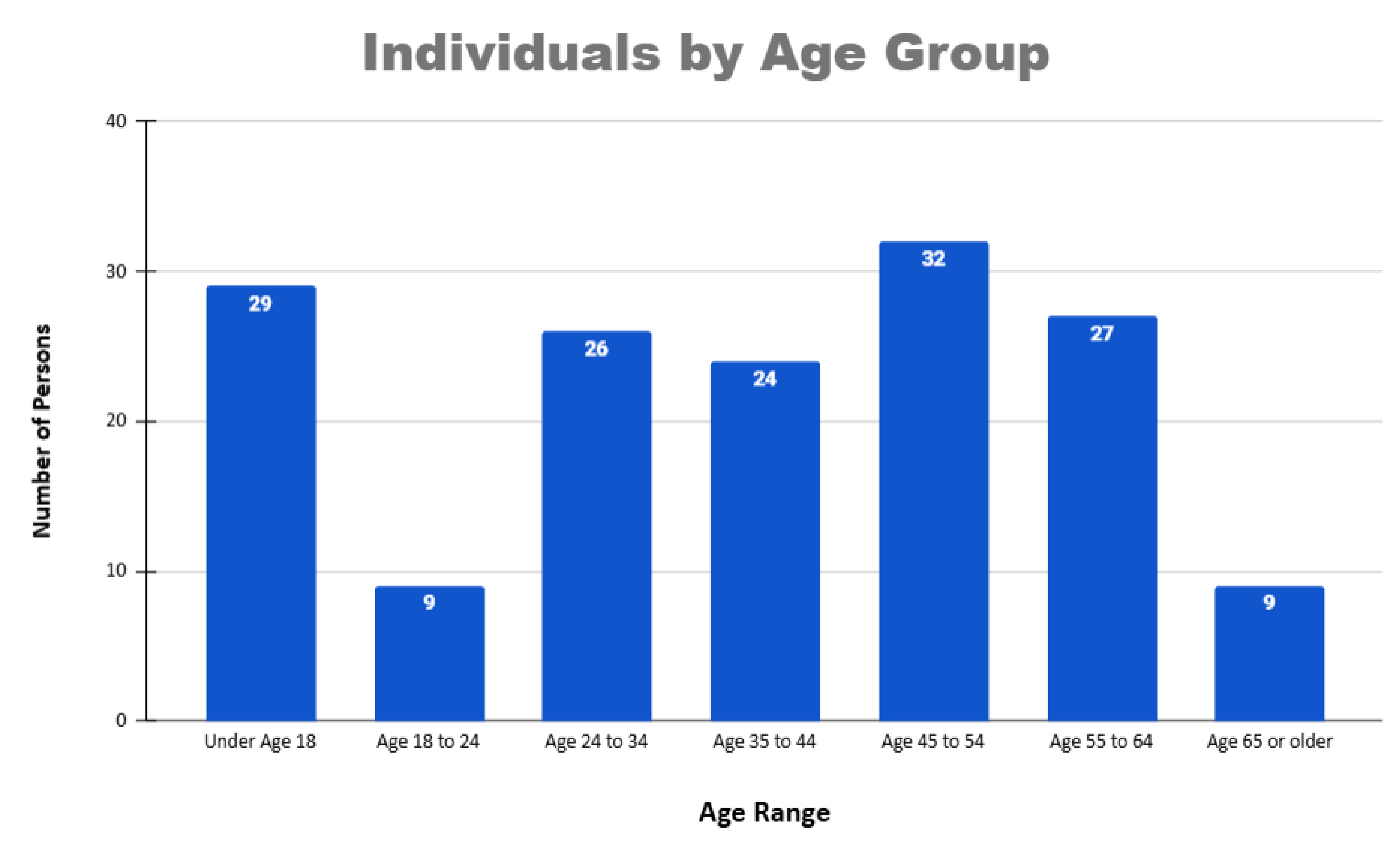
- BEING WITHOUT A HOME FOR AT LEAST A YEAR

- AND HAS A DISABILITY



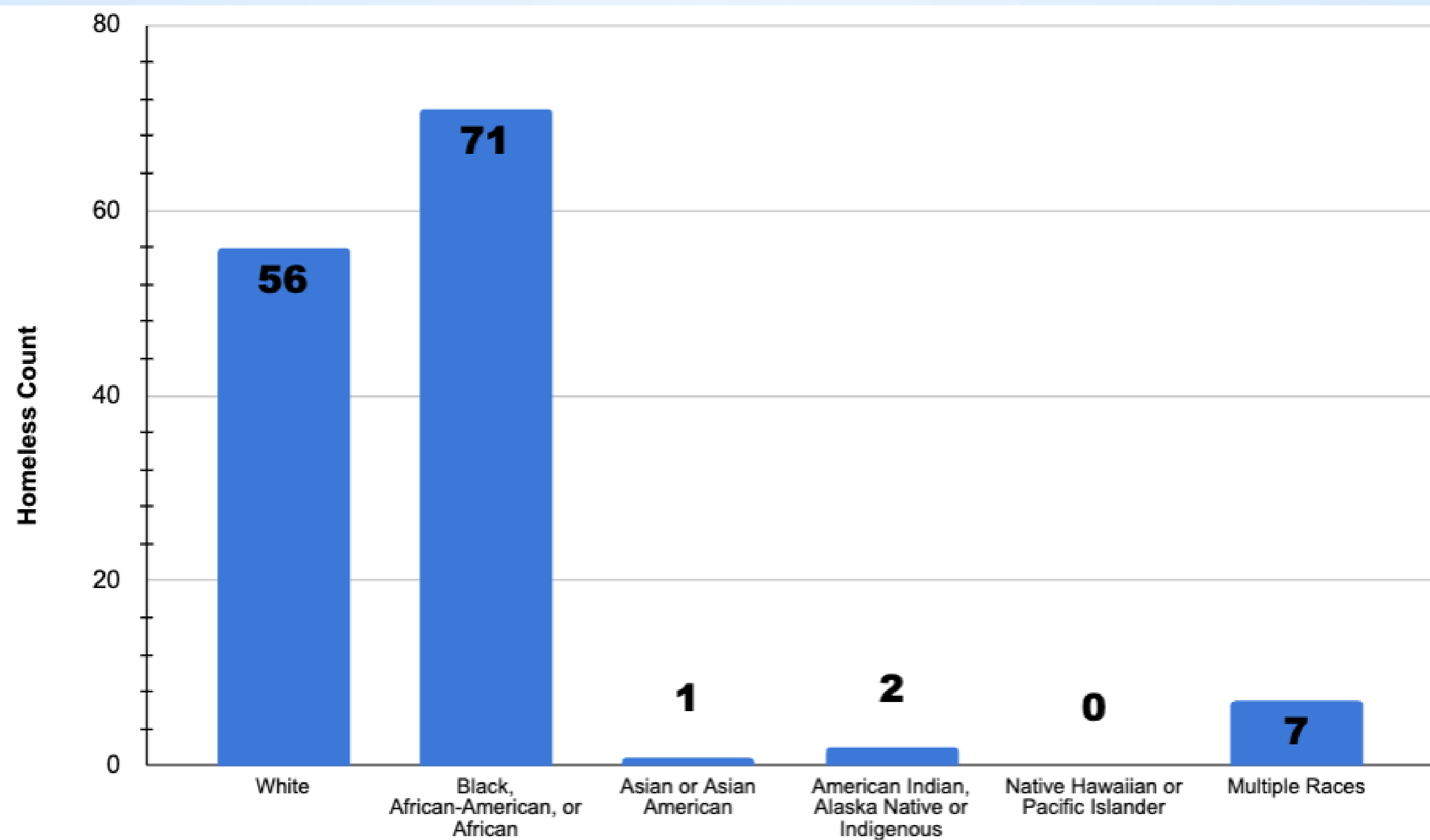
COUNT OF REPORTED CONDITIONS ON PIT



COUNTED INDIVIDUALS BY AGE GROUP

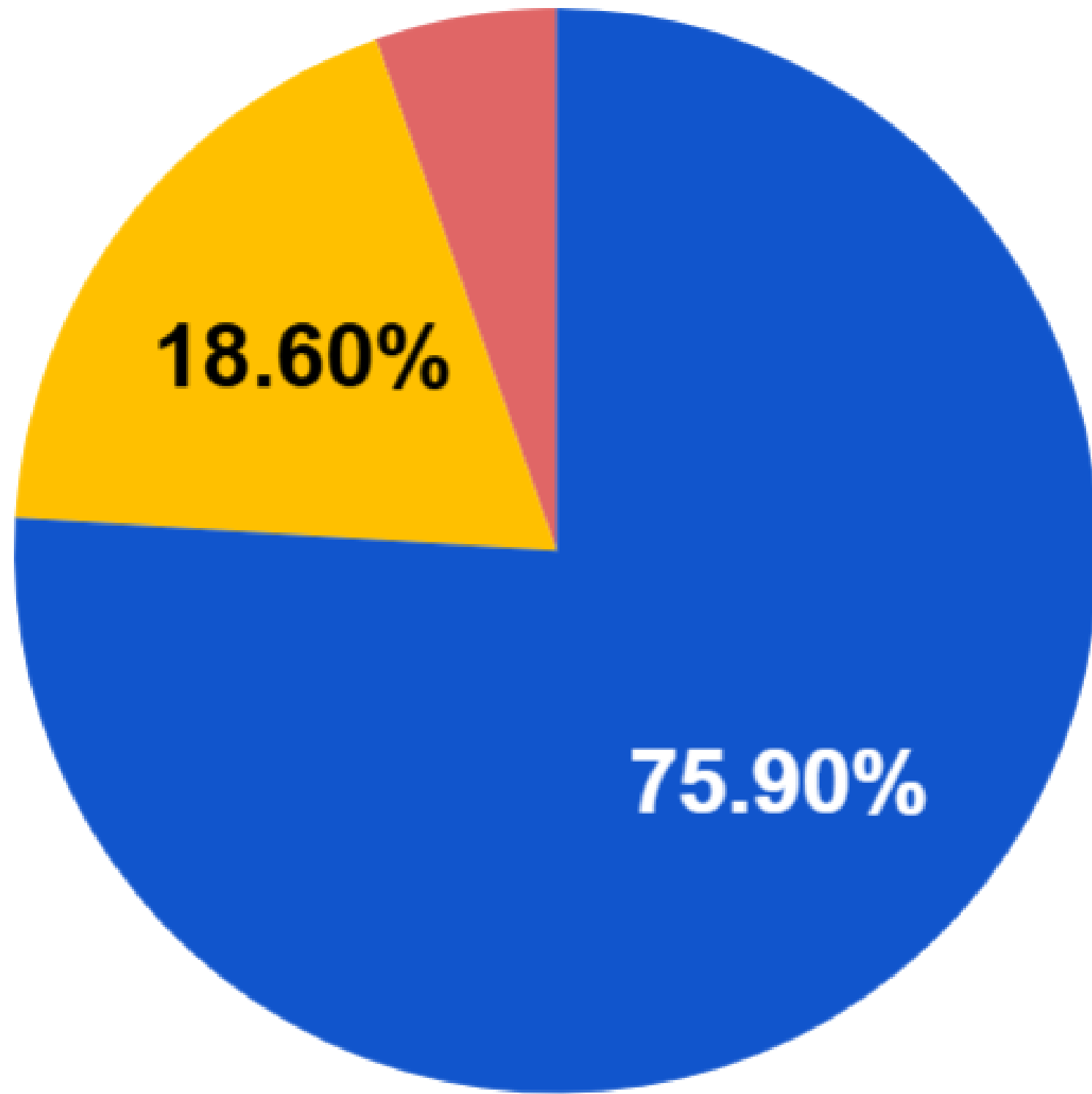


COUNTED INDIVIDUALS BY RACE IDENTITY

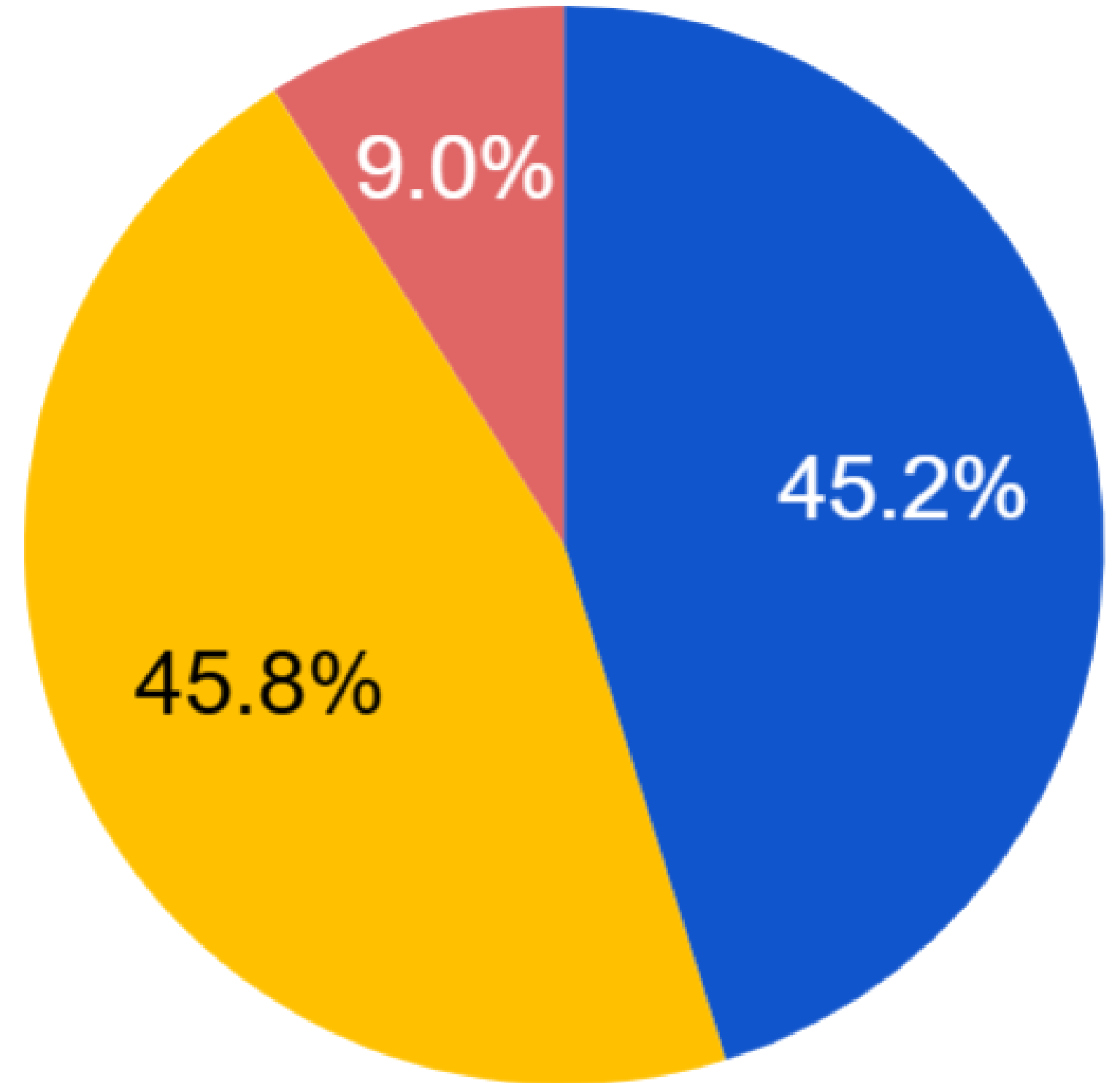

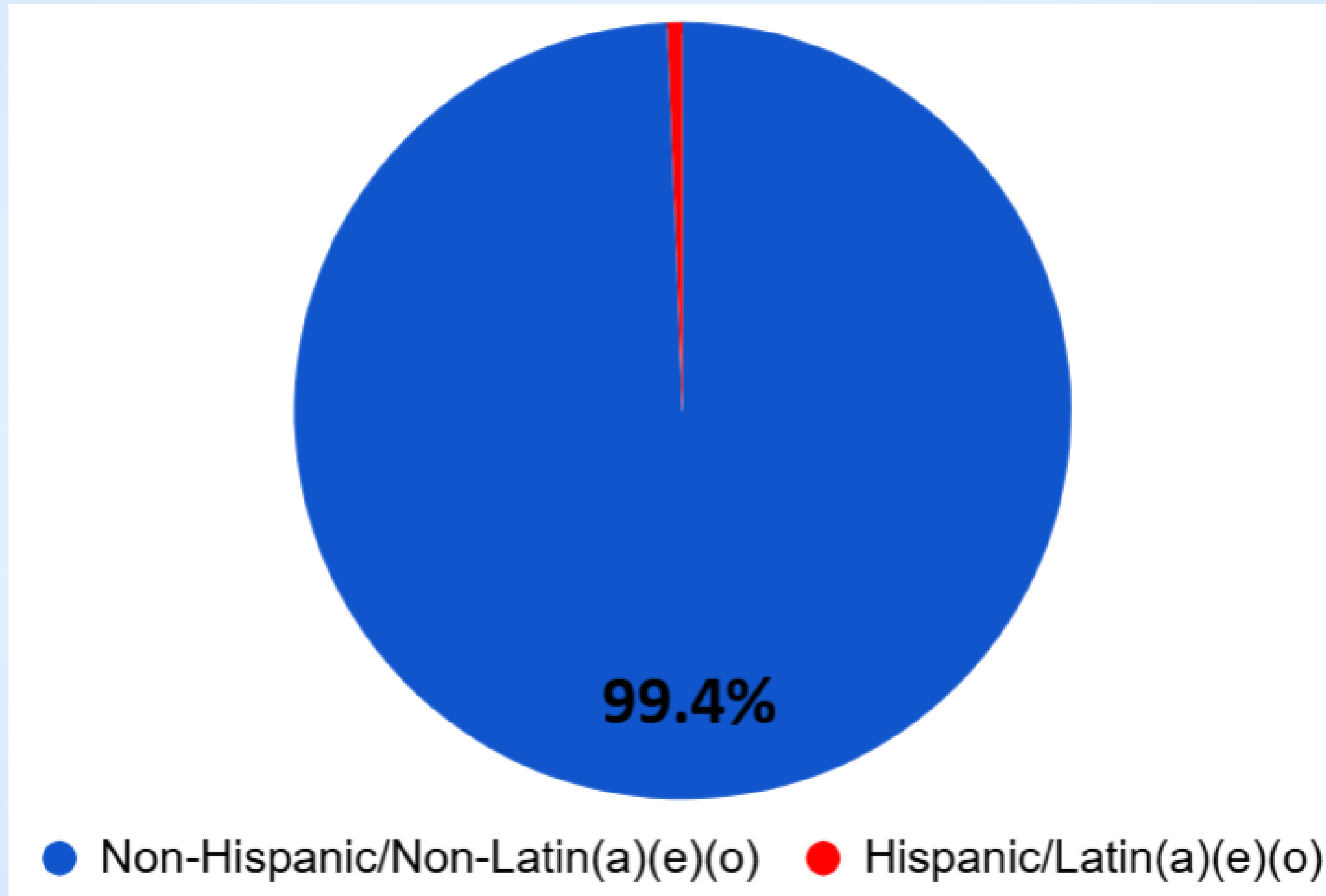

DISTRIBUTION OF REPORTED ETHNICITY

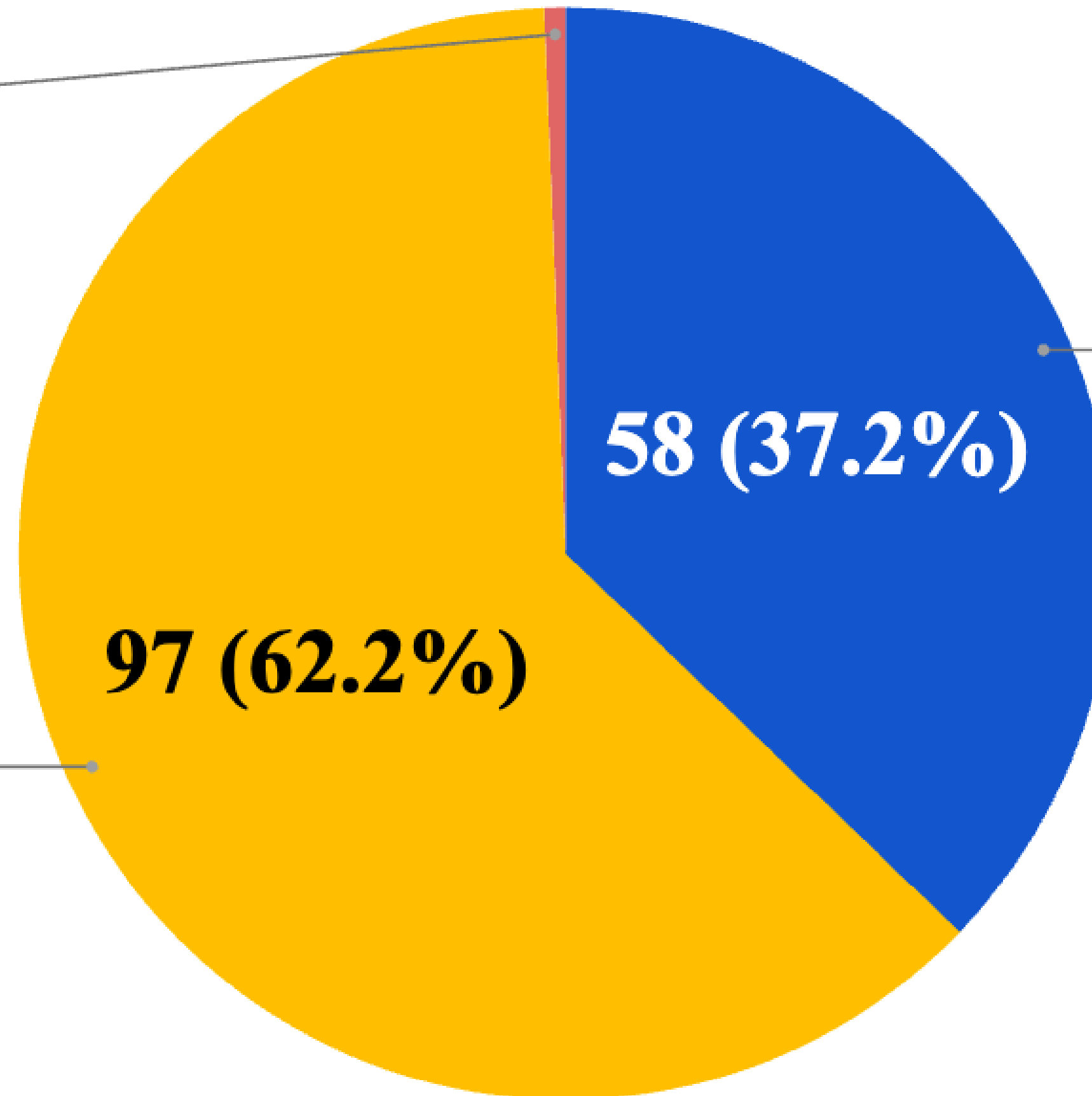


DISTRIBUTION OF GENDER IDENTITY

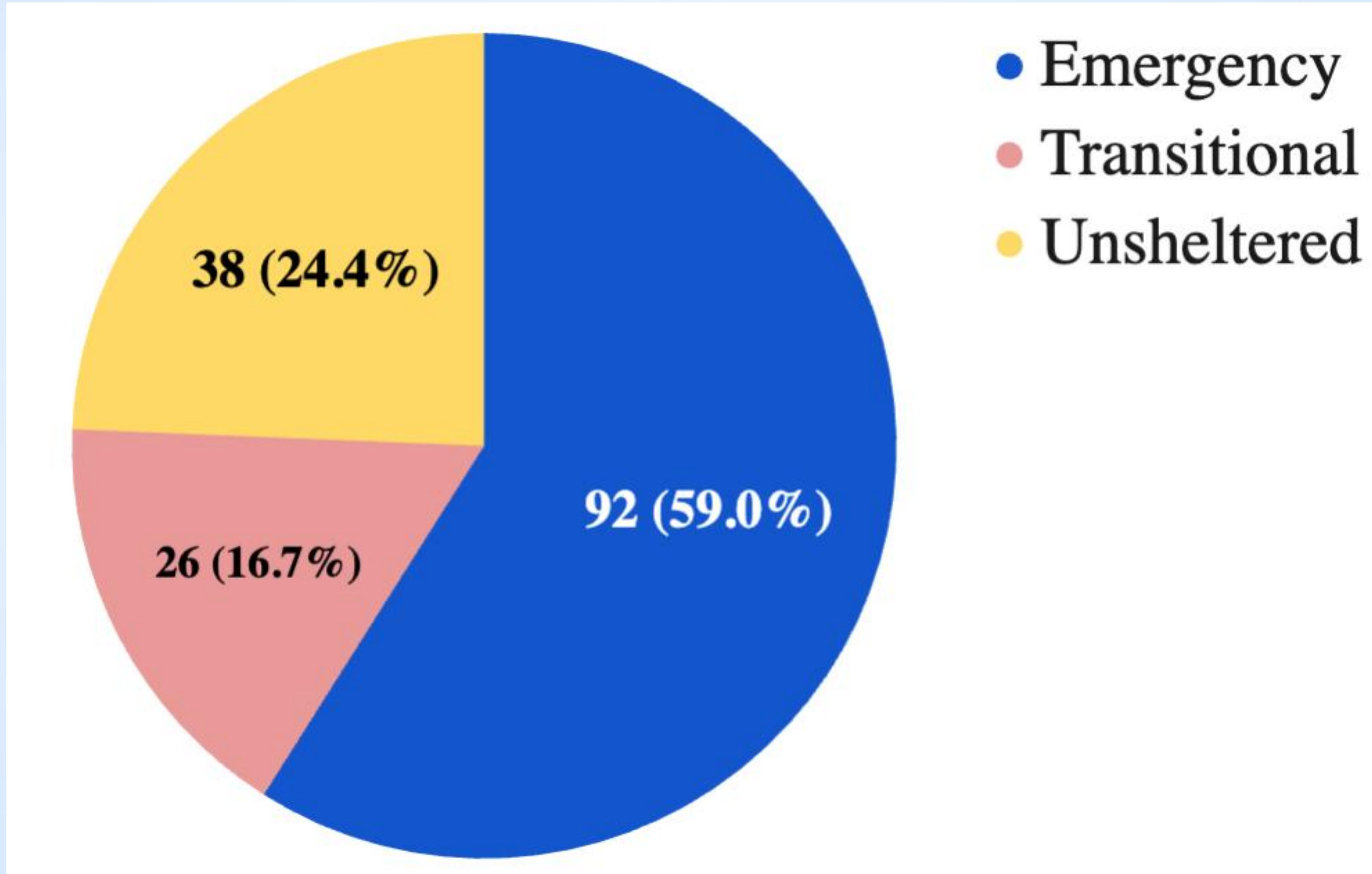

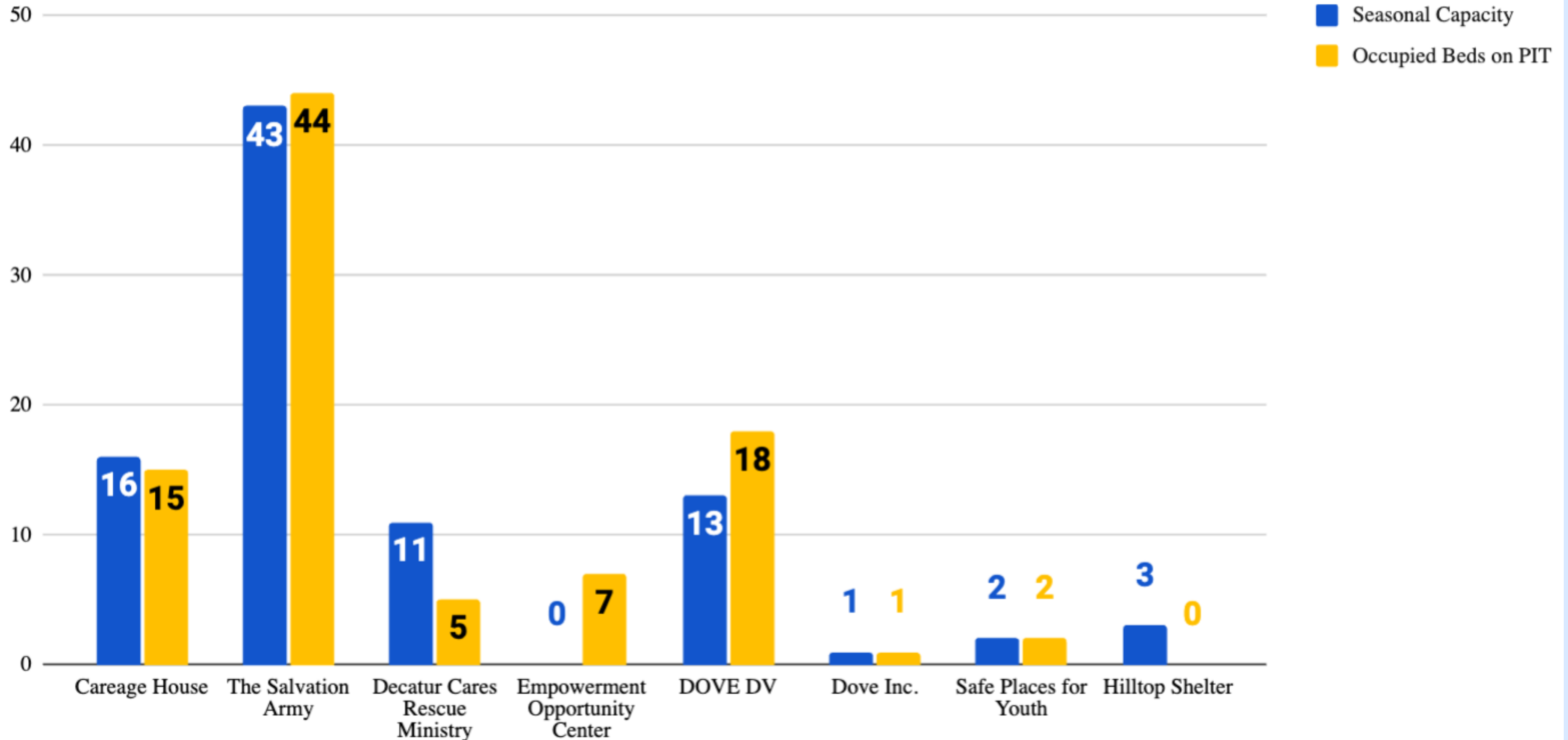


DISTRIBUTION OF SLEEP LOCATIONS



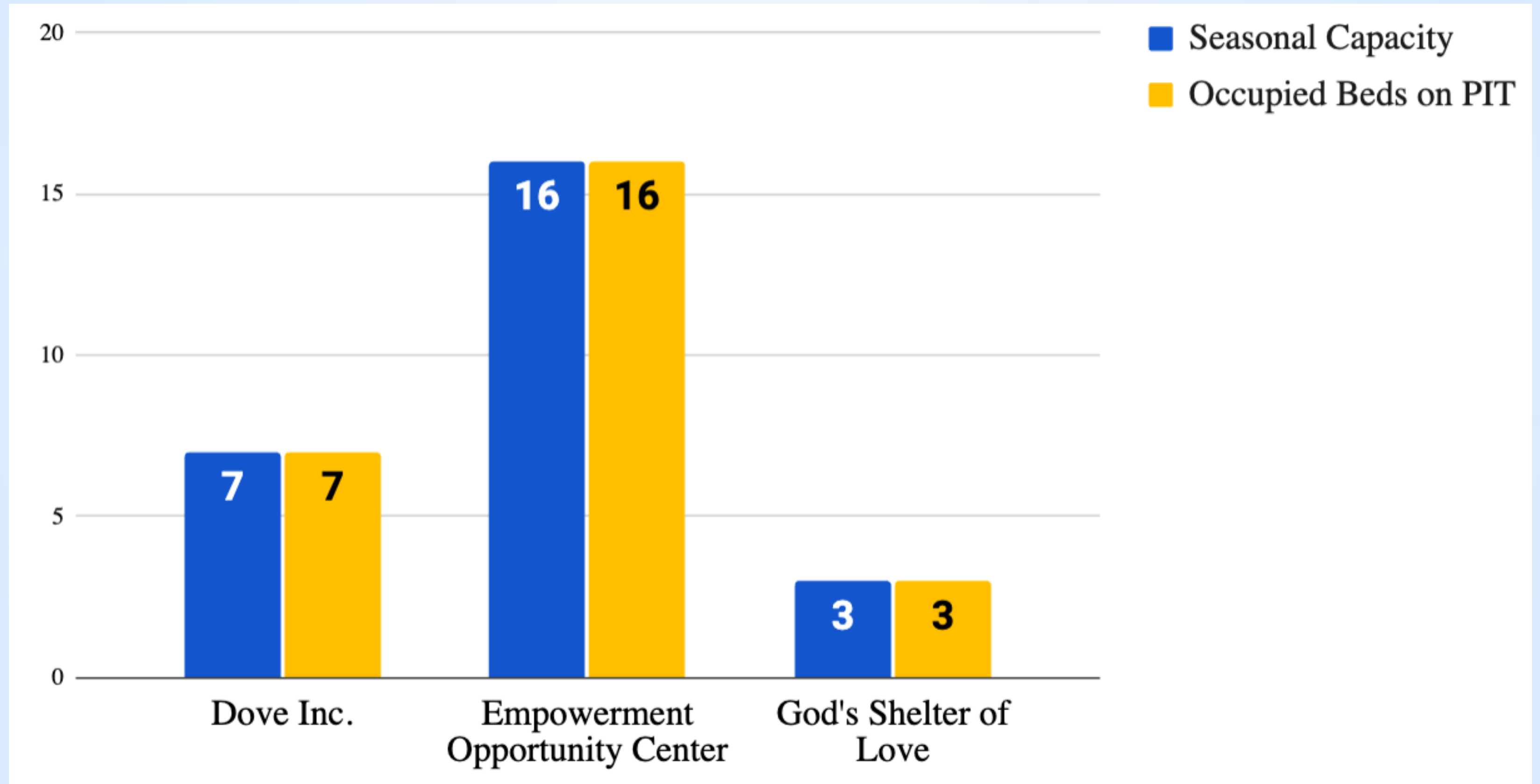
BEDS OCCUPIED ON PIT
